

GUIDELINES FOR PROCESSING AN APPLICATION FOR SIGHT OR HEARING ASSISTANCE
 PROVIDED BY THE WEST VIRGINIA LIONS CLUBS
 OR THEIR SIGHT CONSERVATION FOUNDATION (WVLSHCF)

- CLIENT MAKES REQUEST TO A LION MEMBER
- CLUB COMMITTEE REVIEWS REQUEST
- VISIT WITH THE CLIENT TO RESEARCH NEED AND CRITERIA TO RECEIVE LIONS ASSISTANCE
- CLUB COMMITTEE APPROVAL
- CONFIRM THAT ALL SPACES FOR INFORMATION ARE COMPLETED AND LEGIBLE
- MAIL TO WVLSHCF SERVICE COORDINATOR FOR APPROVAL "ADDRESSES ARE AVAILABLE BELOW"
- COORDINATOR MAILED TO FACILITY PROVIDING SERVICE
- SERVICE PROVIDER WILL THEN DEAL DIRECT WITH THE CLIENT

IT IS THE RESPONSIBILITY OF THE CLUB REPRESENTATIVE SUBMITTING THIS APPLICATION TO CONFIRM THE APPLICANT'S QUALIFICATION FOR ASSISTANCE PLEASE REVIEW THE FOLLOWING WITH THE CLIENT

When your application is referred to a service provider (WVU Eye Institute, Charleston Hospital, Blaydes Clinic and others) and you are interviewed by them, you will likely be required to furnish:

- Financial Statements
- Copies of 4 Consecutive Pay Stubs
- Bank Statements for Checking and Savings Accounts
- Current Income Tax Return
- Medicaid Denial Letter
- Prescription Drug List from your Pharmacy
- Complete Information about your Employer(s)
- Income Beyond your Employment
- Other Cash on Hand
- Property Assets, such as IRAs and Retirement Programs

If you are unwilling to provide this information, you may be denied service.
